

NOTICE OF ELECTION

Police and Crime Commissioner election

For the Devon and Cornwall Police Area

1. An election is to be held for a Police and Crime Commissioner for the Devon and Cornwall Police Area.
2. Nomination papers can be obtained from the office of the Police Area Returning Officer, Exeter City Council, Paris Street, Exeter EX1 1JN during the times stated below.
3. Nomination papers must be delivered to the Police Area Returning Officer at Exeter City Council, Paris Street, Exeter EX1 1JN between 10am and 4pm on any working day after publication of this notice but no later than **4pm on Thursday 7 April 2016**.
4. If the election is contested the poll will take place on **Thursday 5 May 2016**.
5. Applications to register to vote must reach the relevant Electoral Registration Officer by 12 midnight on **Monday 18 April 2016**. Applications can be made online: <https://www.gov.uk/register-to-vote>.
6. The £5,000 deposit can be paid by legal tender or by means of a banker's draft from a drawer which carries on business as a banker in the United Kingdom.
7. Applications, amendments or cancellations of postal votes must reach the relevant Electoral Registration Officer by 5pm on Tuesday 19 April 2016.
8. Applications to vote by proxy at this election must reach the relevant Electoral Registration Officer by 5pm on Tuesday 26 April 2016.
9. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the relevant Electoral Registration Officer by 5pm on 5 May 2016. The physical incapacity must have occurred after 5pm on Tuesday 26 April 2016. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Tuesday 26 April 2016.
